

## Ubuntu Goes Sci-Fi Competition Terms and Conditions

1. The Ubuntu Goes Sci-Fi competition is open to European residents only, aged 18 years or over, except employees of the Promoter, their families, agents or any third party directly associated with administration of the Promotion.

In the instance someone enters more than one entry, only the first entry will be permitted. The winners are chosen by DJ Yoda who will select the best three entries (at his sole discretion).
4. By entering the Promotion, you represent and warrant that your submission:
  - Is your own work and is provided compliant with the age and territorial restrictions set out in clause 1.
